*I ..... hereby and authorise photographer Julia Winter to capture and edit the photography project and related materials (video / movie stills / album / print).*

*The Client is of the opinion that the photographer has the necessary experience and abilities to provide the service and agrees that created project may be edited and otherwise altered at the sole discretion of the Photographer.*

*Photographer authorise the Client to use project and it's parts for personal purpose only. With this agreement the Client shall own all the copyrights for this Intellectual Property with out limitations.*

*The Photographer is agreed to provide private photography service to the Client on the terms and conditions set on this agreement. The services may also include tasks which the parties may agree on.*

*The Photographer agrees to provide photography-video service to the Client and will be payed in full on the day when the shoot takes place.*

*Subject to early disclosure. The term of this agreement will begin on the date of this agreement and will remain in full force and effect, unless assign or other wise transferred with the prior written consent of the client.*

*The photographer will have full control over working time and decision making in relation to service provided, working autonomously and not at the direction of the client.*

*The Client proposes to pay Photographer to create and produce photos/video that are confidential information.*

*Confidential Information shall include all photographs/video, data, materials, products, technology, financial information, and other information about the client disclosed or submitted, orally, in writing, or by any other media, to the Photographer.*

*The Photographer will, on request from the Client, return all copies and records of the Confidential Information disclosed by the other party to the Client and will not retain any copies or records of the Confidential Information as this will be the property of the Client.*

*Upon the request of The Client, Photographer shall return all Confidential Information received in written or tangible form, including copies, or reproductions or other media*

*containing such Confidential Information, within ten (10) days of such request. At clients' option, any documents or other media developed by the Photographer containing Confidential Information/Photographs/Video may be destroyed by photographer.*

*The Photographer shall provide a written certificate to the Owner regarding destruction within ten (10) days thereafter.*

*Photographer agrees not to disclose its participation in this undertaking, the existence or terms and conditions of the Agreement, or the fact that discussions are being held with Client.*

*The obligations of photographer herein shall be effective from the date and time client discloses any Confidential Information to photographer pursuant to this Agreement.*

*Further, the obligation not to disclose, shall not be affected by bankruptcy, receivership, assignment, attachment or seizure procedures, whether initiated by or against the photographer, nor by the rejection of any agreements between client and photographer, by a trustee of Recipient in bankruptcy, or by the Recipient as a debtor-in-possession or the equivalent of any of the foregoing under local law.*

*The English Courts will have non-exclusive jurisdiction to deal with any dispute which has arisen or may arise out of, or in connection with this Agreement.*
